BLAIR COUNTY ARTS FESTIVAL AT PENN STATE ALTOONA ELIGIBILITY REQUIREMENTS

You must be at least 18 years old to enter. Work must not have been shown previously at Blair County Arts Festival and must be the original work of the artist submitting the entry & not derived from the copying of another's art or from kits.

AWARDS

A total of \$3,000 will be awarded at the Juror's discretion, during the Artist Reception at Penn State Altoona.

JUROR

Jeffrey P. Rouse is the owner of New Growth Gallery & Tri-Maple Studios in New Alexandria, Pennsylvania. He received a B.A. in painting from I.U.P. and an M.A. in American Art History and Painting from the University of Pittsburgh. He is a bonded fine arts appraiser and is best known for his mural painting and "Stations of the Cross" project at St. Patrick's Church in Erie, Pennsylvania

ENTRY PROCEDURE Submit the following to BCAF

- Completed Application Form for each category.
You may enter 3 pieces of artwork in each category, but please use a separate form for each category.
- Check or Money Order for appropriate entry fee, made payable to BCAF.
- Self-addressed **STAMPED** envelope with sufficient postage to return Juror's decision.
If a self-addressed stamped envelope is not included with your application, you will not receive the Juror's decision on your artwork, and you will be disqualified.
- One CD, containing all images of work by artist. (**No Slides - CDs ONLY will be accepted**).
Only one CD must be accompanied by official entry form and contain all images of work by a single artist.
Titles of works on CD must match titles on entry form.
Each image may not exceed 1GB in size. File form must be in jpeg format and open with Internet Explorer.
Deviation or incompleteness is grounds for disqualification.
Have a friend **SUCCESSFULLY** open you CD in their computer before submitting it for entry.
Include your email on your CD, if in doubt. CDs will not be returned.

CATEGORIES & SPECIFICATIONS

Two Dimensional Includes oil, acrylic, and water color painting; drawing; mixed media works on canvas or paper; digital art; and graphic disciplines (intaglio, lithography, screen printing).

Three Dimensional Includes sculpture and all craft categories... ceramics, glass, fiber, basketry, etc.

Photography Includes framed prints.

PRESENTATION

Two Dimensional work requiring covering must be protected by glass/acrylic.

Photography must be protected by glass/acrylic.

All 2D & Photography work must be wired and ready to hang.

Due to staging, all work must not exceed 54 inches in H. W. D. Includes ALL categories. No exceptions.

All works must be available for sale. A 20% commission will be charged on works sold from the exhibition.

FEES

There will be a \$20 fee for each category. You may enter all 3 categories. Entering 3 categories = \$60.

Note that there is a limit of 3 pieces of artwork in each category.
